Dear Huron School District Voter:

By now you have received your absentee ballot application for the November 8th election. Many of you will be receiving your actual ballot in the mail. There are two very important issues on the ballot. First, you will be voting for (2) one-year terms and (2) four-year terms on the Huron School District Board of Education.

The second issue is the renewal of the Non-Homestead operating millage; this is required for the district to receive its revenue per pupil foundation allowance. This renewal directly supports our children and local schools. It is only assessed on **commercial, industrial, and non-primary residential property**. It is **NOT** a millage on your primary home and does **not** appear on your tax bill. We urge you to vote on this renewal. The renewal of this millage is essential to the children of Huron Township.

- This millage represents \$2, 245,876 or 10% of the school district's annual operating budget.
- These funds are collected as part of the per pupil foundation allowance for Huron School District children only. The State of Michigan mandates this millage for our students to receive their full funding.
- This is **NOT** a new millage on commercial or industrial property.
- A **"NO"** vote will not cause your property taxes to go down.
- A **"YES"** vote will not cause your house taxes or the taxes on business to go up.
- The renewal is for 5 years only.

Please mark your absentee ballot and return it to the Huron Township Clerk's Office as soon as possible. If you plan on voting in person, please contact the Huron Township Clerk to confirm your precinct.
